(c) On the grounds that coercing the conscientious objector into paying for war through the tax system infringes on the United Nations Declaration of Human Rights and limits the right to freedom of thought, conscience and religion.

(d) On the grounds that there is a moral equivalence between taking someone's life and paying someone else to do so, and that this is recognised in our current judicial system. (e) On the grounds that sustainable peace can only be achieved with development and diplomacy, and that militarism only serves to exacerbate conflict, that investment in the development of arms for means of deterrence only serves to continue a culture of death and destruction, and that non-violent conflict resolution is a more ethical, economic and effective foreign policy. Military taxation is therefore a waste of the woman/man's money.

Men who applied for conscientious objector status in WW1 had to prove their sincerity of conscience through written statements and verbal arguments at tribunals. Although there is no longer conscription in this country, there is a continued need to make our conscience heard as the state takes our financial involvement in war and preparation for war for granted. **Please write your own statement of conscience below,** detailing your opposition to financial conscription. We will include it in a volume of personal testimony in support of the Taxes For Peace Bill 2016, demonstrating why the right of conscientious objection needs to be extended. **The only way we can make it matter to politicians is by showing it matters to you.**
