Your peace tax return

This form is for people who have a moral or religious objection to military spending on the grounds of conscience and wish to declare their objection to the UK government. It is not an official HMRC form, but we believe it should form part of the official tax return produced by HMRC.

How to file your peace tax return

Instructions for Part A: Part A is for those people who wish to protest against their taxes paying for war, but do not or cannot try and withhold or divert the 10% of their taxes that contribute to military spending.

Instructions for Part B: Part B is for those people whose conscience directs them to withhold or divert the 10% of their taxes that contribute to military spending. **Please note that withholding or diverting taxes due is likely to incur financial costs and may result in legal action being taken against you.**

For those who File a Paper Tax Return: please read the whole form before signing and dating the relevant part. Then attach the form to your tax return. To make this peace tax return a formal part of your official HMRC Tax Return you should make reference to your conscientious objection in the

'Any other information' box (box number 19, page TR 6) of your tax return by inserting the words "Please see attached declaration of conscientious objection to military taxes" or similar.

For those who File their Tax Return Online: please read the whole form before signing and dating the relevant part. To make this peace tax return a formal part of your official HMRC Tax Return you should make reference to your conscientious objection in the 'Any other information' box of your tax return by either inserting the words of 'Part A' or 'Part B' or stating that you have posted a "declaration of conscientious objection to military taxes" to HMRC and wish for it to be attached to your Tax Return.

For those Under the PAYE Scheme: you can also complete this form to show your protest to paying for war. Please read the whole form before signing and dating the relevant part, then post your completed form to: HMRC, 1 Horse Guards Road, London, SW1A 2HQ.
